#### The general state of administration of justice in Ukraine

> 17% (135) of courts changed their territorial jurisdiction due to the impossibility of administering justice during the war

> 7 % (59) of the total number of courts and 43 % of the courts that changed their territorial jurisdiction have already restored it


#### The general state of administration of justice in Ukraine

> the judicial system lacks 2,227 judges

➤ 226 judges were dismissed between January and September 2023


➤ a call for applications for 560 vacant positions in local general courts has been announced

#### Statistics of cases submitted to the courts



The beginning of Russia's full-scale invasion of Ukraine has led to a sharp decrease in the number of citizens' appeals to the courts to protect their rights. Thus, in 2022, the courts of Ukraine received 2 million 865 thousand cases and materials for review, which is 34% less compared to 2021 (4 million 356 thousand cases and materials).

#### Statistics of cases submitted to the courts



In this regard, the total volume of cases and materials received by the courts for review in the first half of 2023 has increased by 82% (2 million 113 thousand) compared to the same period in 2022 and reached the level of 2021.

In the first half of 2023, the courts reviewed a total of 1 million 946 thousand cases and materials of all jurisdictions (70% of those pending).

### Criminal proceedings for crimes against the national security of Ukraine


- ➤ As of November 20, 2023, 16,000 crimes against the national security of Ukraine have been reported
- > 5,933 proceedings were brought to court:
  - $\checkmark$  2,265 were reviewed by the courts of first instance
  - ✓ 129 were reviewed by the courts of appeal

#### Criminal proceedings for crimes of aggression and war crimes


- > As of 21 November 2023, more than 113,000 war crimes have been registered
- > 1,499 proceedings were brought to court:
  - ✓ 1,089 reviewed by courts of first instance
  - ✓ 64 reviewed by courts of appeal
  - ✓ several in cassation

## Typical cases under Art. 438 of the Criminal Code of Ukraine "Violation of the laws and customs of war"

- ☐ intentional killing of civilians
- ☐ ill-treatment of civilians
- □ robbery, destruction of property
- ☐ destruction of civilian/critical infrastructure, residential buildings
- ☐ attacking a civilian object, unlawful deprivation of liberty of civilians
- giving orders to violate the laws and customs of war

# Special procedure of criminal proceedings (in absentia)


✓ 75% of criminal proceedings under Article 438 of the Criminal Code of Ukraine were conducted in the absence of the accused

✓ 25% of criminal proceedings under Article 438 of the Criminal Code of Ukraine were conducted in the presence of the accused

## The range of evidence confirming the guilt of a person convicted under Article 438 of the Criminal Code of Ukraine

- ✓ testimony from victims, witnesses, and the accused
- ✓ material evidence
- ✓ electronic evidence
- ✓ expert opinions (in 46 % of verdicts)
