



RATIONALE FOR MAKING CHANGES TO THE NATIONAL CLASSIFIER OF UKRAINE "CLASSIFIER OF OCCUPATIONS" WITH REGARD TO THE LEGAL PROFESSION

Rationale for Making Changes to the National Classifier of Ukraine "Classifier of Occupations" with regard to the Legal Profession

Introduction

For a few years already, legal professionals and experts have been actively discussing the need to develop a new National Classifier of Ukraine "Classifier of Occupations" (hereinafter the Classifier of Occupations) with regard to the legal profession. This discussion started due to the fact that the methodological principles and criteria used to determine the types of professional activity belonging to the legal profession in the current Classifier of Occupations do not reflect the modern understanding of the role and professional functions that are entrusted to a lawyer in a democratic society.

In 2022-2024, the Ukrainian Bar Association, with support of the USAID Justice for All Activity, held several discussions of the Classifier of Occupations with regard to the legal profession. More than 300 people took part in the aforementioned discussions, including representatives of the National Qualifications Agency, the Ministry of Economy of Ukraine, the Ministry of Justice of Ukraine, law schools and other stakeholders. In the process of these discussions, some participants stated the need to make changes to the Classifier of Occupations in the part concerning the legal profession, taking into account the methodological principles regarding the nature of professional activity and qualifications, as well as the structural architecture of the relevant professional groups and subgroups.

It should also be noted that the current Classifier of Occupations is based on the methodological principles of the International Standard Classification of Occupations (ISCO 88), which is currently not in use, as there is already a new edition of the International Standard Classification of Occupations (ISCO 08, hereinafter the International Classifier of Occupations). Therefore, the Cabinet of Ministers of Ukraine created by its Resolution No. 781 of 12 July 2022 the Interdepartmental Working Group on Reforming the National Classifier of Ukraine DK 003:2010 "Classifier of Occupations" (as a temporary consultative and advisory body of the Cabinet of Ministers of Ukraine) and defined its tasks as follows:

- 1) to develop the concept of reforming the National Classifier of Ukraine DK 003:2010 "Classifier of Occupations" with the aim of harmonising it with international standards for the classification of occupations, professions, professional qualifications, education and bringing it into line with the International Classifier of Occupations (ISCO 08);
- 2) to align the positions of stakeholders regarding the functions, structure and content of the Classifier of Occupations.

In March 2023, the Ministry of Economy of Ukraine, the Ministry of Justice of Ukraine and the National Qualifications Agency offered their support to the Ukrainian Bar Association (UBA)'s intention to prepare comprehensive recommendations regarding the Classifier, supplement them with draft standards of legal professions and hold professional expert discussions.

For Ukraine, it is currently important to ensure that the Classifier of Occupations be a systematised list of occupations created in accordance with international standards. This is necessary to ensure recording and comparing occupations both at the national level and on the global labour market. A well-designed Classifier of Occupations is important for conducting statistical studies, matching labour supply and demand, managing labour migration, planning vocational education development, administering various social and labour processes, as well as for other administrative, statistical and informational purposes regarding trends in the labour market.

Since the Classifier of Occupations applies to all areas of economic and social activity and its use is mandatory to indicate the occupation when drawing up official documents where such indication is required, it is therefore very important to correctly outline what types of professional activity are covered by the concept of the relevant occupation, in our case – the legal profession.

Rationale

In the current Classifier of Occupations, the group "Legislators, senior civil servants, senior managers, managers" includes as subgroups occupations related to administration of justice and prosecutorial oversight. The list of positions specified in the subgroup "Senior judicial officials" no longer reflects the current legislation and the functions they perform, since, according to international standards, it should be a matter of professional specialisation in the performance of policy-making functions in the field of the judiciary, and as well as an independent subgroup of senior managers and managers in the field of law. In the "Professionals" group, the current Classifier of Occupations provides for the subgroup "Professionals in the field of jurisprudence, prosecutorial supervision, justice and law enforcement activities." Combining representatives of occupations that perform completely different professional functions in this subgroup is also unjustified. We believe that the approach used in the International Classifier of Occupations, where the subsubgroup "Lawyers" is included in the subgroup "Legal, social and cultural professionals," is more justified.

It should also be noted that the amendments to the Constitution of Ukraine of 2 June 2016 introduced such concepts as "the legal profession" (Article 131) and "lawyer" (Article 148). Therefore, in the new version of the Classifier of Occupations, it is

necessary to highlight the legal profession and those who belong to it according to the nature of the functions and the corresponding level of qualification. In order to determine which types of professional activity are covered by the legal profession and exactly how they should be reflected in the Classifier of Occupations hierarchically, we assume that for the definition of a profession, it is important to outline a set of homogeneous tasks and functions performed by representatives of this profession and requiring an appropriate level of knowledge and skills/abilities acquired as a result of training and/or practical work, which provides us precisely with the opportunity to demarcate the legal profession for both statistical and administrative purposes.

To determine the types of professional activity covered by the legal profession, we relied on the practices of democratic nations in which lawyers perform the functions of applying and interpreting the law, as well as the functions of legal experts in the process of creating law. We have also included in the legal profession those whose professional activity consists in providing professional assistance to those who directly apply the law.

This approach, with certain modifications arising from national traditions, can be seen in the classifiers of occupations of European countries, which are based on the International Classifier of Occupations. We have analysed the position classifiers of Poland, Lithuania, Latvia, the Czech Republic, and Hungary, which with regard to the legal profession are aligned with the International Classifier of Occupations.

In the proposed draft changes to the Classifier of Occupations with regard to the legal profession, we propose to include **in the first basic group** those whose professional functions and tasks are related to the development and formation of state policy in the field of law and/or management and organisation of activities to implement such policy.

In the second basic group, we propose to include those whose professional functions presuppose the ability to solve tasks of a research and/or innovative nature in the field of application and interpretation of law, as well as expert activity in the field of creation and application of law.

In the third basic group, we propose to include those whose professional functions are related to activities that require applied knowledge and experience in professional assistance to those who carry out activities related to the application and interpretation of law.

Streamlining the Classifier of Occupations with regard to the legal profession is important for the systematisation of qualification requirements for access to certain types of professional activity, the preparation of professional and educational standards in the field of law, and the understanding of characteristic features to be used for determining the length of professional experience in the field of law, as well as for a number of other socially significant goals.

Stages of preparation of the change proposals

The proposed draft changes were actively discussed in October – December 2023 in the professional community with the participation of judges, prosecutors, lawyers, notaries, legal advisers and legal scholars. More than 200 lawyers joined the discussions, including our colleagues from the city of Kyiv and Kyiv oblast, Vinnytsia, Volyn, Dnipropetrovsk, Zhytomyr, Zaporizhzhia, Zakarpattia, Ivano-Frankivsk, Kirovohrad, Lviv, Mykolaiv, Odesa, Poltava, Sumy, Kharkiv, Kherson, Khmelnytskyi, and Chernihiv oblasts. Representatives of the Interdepartmental Working Group on Reforming the National Classifier of Ukraine DK 003:2010 "Classifier of Occupations (Yu. Balaniuk) and the National Qualifications Agency took part in the meetings as well.

Besides, in January – April 2024, the Ukrainian Bar Association received comments and suggestions for improving the prepared changes from key stakeholders. In particular, we noted valuable advice from the Office of the Prosecutor General, the High Council of Justice, the State Judicial Administration of Ukraine and the Council of Judges of Ukraine.

We have incorporated most comments:

- regarding the classification of the Prosecutor General, Deputy Prosecutor General, Deputy Prosecutor General Head of the Specialised Anti-Corruption Prosecutor's Office and Deputy Head of the Specialised Anti-Corruption Prosecutor's Office with the "Senior Government Officials" subgroup
- regarding the classification of trainee prosecutor in the "Legal professionals not elsewhere classified" subgroup

We have also clarified names of certain groups and subgroups.

Non-incorporated proposals include:

• The proposal to introduce the positions of the First Deputy Prosecutor General and the First Deputy Head of the Specialised Anti-Corruption Prosecutor's Office into the Classifier of Occupations does not comply with the methodology of the International Classifier of Occupations, which recommends to avoid including the entire range of positions related to professional activity of a certain level and qualification in the list of occupations.

We present proposals to the Classifier of Occupations with regard to the legal profession as a comparison table comparing them with the International Classifier of Occupations (Annex 1).

We propose to submit the agreed-upon draft changes to the Classifier of Occupations with regard to the legal profession to the Interdepartmental Working Group on Reforming the National Classifier of Ukraine DK 003:2010 "Classifier of Occupations" for consideration in the process of developing the concept of reforming the Classifier of Occupations and its substantive content with regard to the legal profession in accordance with the International Classifier of Occupations.

Proposed changes to the current Classifier

The Ukrainian Bar Association has carried out a colossal work (see above) on the development of proposals for changes to reform the Classifier of Occupations of Ukraine DK 003:2010 with regard to the legal profession with the aim of harmonising it with international standards and bringing it into line with the International Classifier of Occupations (ISCO 08).

At the same time, we have learned that changes are currently being prepared to the current Classifier of Occupations which are based on the methodological principles of the International Standard Classification of Occupations (ISCO 88).

Therefore, we have presented in **Annex 2** our expert recommendations reflecting proposals for improving the current Classifier of Occupations. It is important to note that these proposals are an interim version, reflecting only the UBA's expert vision of possible improvements. They are not final solutions, but rather an important stage on the way to a full-fledged reform of the Classifier.

Our ultimate goal is to adapt the Classifier to international standards, in particular to the ISCO 08 classification, which is a modern and comprehensive tool for describing occupational categories. The transition to new standards will enable us to ensure greater accuracy and compliance with modern demands of the labour market, which, in turn, will contribute to the improvement of management decisions and labour efficiency.

This subgroup lists senior government officials who carry out management activities for the implementation of policies in prosecutor's offices and exercise administrative functions in higher courts and judicial self-government bodies. By its functions, this professional activity does not belong to the legal profession, and according to the qualification requirements, it may require a master's (second) degree either in the "Law" field or in the "Management and Administration" field.

This subgroup lists senior managers who organise the work of a court office. By its functions, this professional activity does not belong to the legal profession as well, and according to the qualification requirements, it may require a master's (second) degree either in the "Law" field or in the "Management and Administration" field.

This subgroup lists senior managers of law firms, that is, those who plan, direct and coordinate the provision of legal services. By its functions, this professional activity

does not belong to the legal profession as well, and according to the qualification requirements, it may require a master's (second) degree either in the "Law" field or in the "Management and Administration" field/ "Social and Behavioural Sciences" field.

This subgroup lists professional lawyers, i.e. those who apply and interpret the law or act as experts in the process of creating or applying the law, as well as those who professionally assist the former in performance of these functions. By its functions, this professional activity is part of the legal profession, and according to the qualification requirements, it should always require a master's (second) degree in the "Law" field.

These subgroups list professionals who assist in the provision of technological and applied services in the field of law. By its functions, this professional activity does not belong to the legal profession as well, since it has no direct links to application of law and according to the qualification requirements, it may require a bachelor's (first) degree either in the "Law" field or in the "Management and Administration" field.
