



THE BOARD AND SECRETARIAT

2021 was a year of changes for the UBA. On July 2, 2021, during the 10th Western-Ukrainian Legal Forum, the elections of the UBA President and the Board were held in Lviv. According to the election results, the Board was almost completely renewed — by 85%. For the first time in the history of the UBA, a woman became the President - Anna Ogrenchuk, managing partner of LCF Law Group. The composition of the Board is also genderbalanced — 10 of the 19 members are women.

According to the Statute of the UBA, the Board consists of 19 persons - 8 members are elected from the Association's branches, 8 — from the sections, and 3 become ex-officio board members (President, Vice-President and retired President). The Board of the Association is elected for a term of 2 years.

COUNTERING AGGRESSION OF THE RUSSIAN FEDERATION

Call for isolation and sanctions against the aggressor countries

The work on countering Russian aggression became the main priority in the activities of the UBA in 2022. Acting on behalf of the legal community of Ukraine, the UBA succeeded in synchronizing the efforts of Ukrainian lawyers and international and foreign legal associations, thus forming a united legal front. The UBA became the legal voice of Ukraine abroad, communicating the issue of the urgent introduction of economic and financial sanctions against the Russian Federation and Belarus, calling for the refusal of cooperation with Russian business, advocating the creation of the Special International Tribunal for the Crime of Aggression Against Ukraine, and many other measures.

For this purpose, the Association prepared and published about 50 statements, positions, and letters addressed, in particular, to parliaments and other authorities of numerous countries worldwide, international legal organizations, civil society and business. Dozens of events, a communication campaign and regular communication with foreign and national media have formed a community of like-minded people who consistently insist on applying all measures of international law to end the war and on the inevitability of punishment for all guilty.

As a result of the UBA efforts, on July 19, 2022, the New York State Bar Association approved a resolution prepared jointly with the UBA, in which it called on the UN General Assembly to take action by authorizing the UN Secretary-General to establish a tribunal(s) to consider the issue of violations of international law by the Russian Federation and committing, among other things, the crime of aggression against Ukraine and bringing guilty persons to justice. On August 9, 2022, the American Bar Association approved a similar resolution in which it called on the UN General Assembly to invite the UN Secretary-General to quickly report on "what further measures are necessary to ensure the prosecution of those who have committed war crimes, crimes against humanity, genocide and the crime of aggression".

The legal ratings of Chambers and Partners and The Legal 500 EMEA excluded Russian and Belarusian law firms from the rating for 2022. The International Bar Association, the American Bar Association, and the New York State Bar Association issued statements that clearly indicated the illegality of the military invasion and the inadmissibility of the arguments of the Russian Federation. For its part, the Solicitors Regulatory Authority of England and Wales has updated its regulation and clearly allowed solicitors to refuse to represent interests or terminate contracts, among other things, on ethical grounds.

Hundreds of lawyers and law firms in Ukraine and around the world have made a conscious choice to stop providing legal services to Russian individuals and legal entities under sanctions, as well as to those who, by paying taxes in the Russian Federation, silently support the Kremlin's policy of aggression.

Support to the creation of the Special Tribunal for the Crime of Aggression **Against Ukraine**

Since aggression, or the "mother of all crimes," is a cause and a factor that enabled the commission of war crimes, crimes against humanity, and alleged genocide that continue today, responsibility for this crime must occupy a central place in the system of public international law.

As of today, none of the mechanisms of international law and the existing international judicial institutions — the International Criminal Court, the International Court of Justice, the European Court of Human Rights — have jurisdiction over the investigation and prosecution of the crime of aggression against Ukraine. If the system of international public law, built since the beginning of the World War II, was not able to prevent an essential crime of the Russian Federation against Ukraine, then it must be reformed in view of the realities of the war in Ukraine.

That is why, from the very first days of the war, the UBA supports the establishment of the Special Tribunal for the crime of aggression against Ukraine. For this purpose, the UBA:

published a position on the Tribunal



repeatedly addressed the authorities of European countries and the world



initiated and supported petitions for the establishment of the Tribunal





organized dozens of events devoted to the establishment of the Tribunal



Finally, the Association actively supported the activities of the Global Accountability Network — a society that includes the best experts in the field of international justice — in promoting the model of the Tribunal established with the support of the United Nations

Collection of evidence of war crimes

The UBA and the International Bar Association (IBA) collect evidence of war crimes by using the IBA EyeWitness to Atrocities app, which automatically generates metadata (exact time and geolocation) during recording. Thus, all the information uploaded to the app is ready to be used as evidence and does not require additional manual processing.

In 2022, 6 UBA and IBA coordinators advocated the usage of the app in different regions of Ukraine (Zaporizhia, Kharkiv, Sumy, Chernihiv, Odesa, and Mykolaiv) and directly documented evidence of crimes. Numerous meetings were held with authorities, law enforcement agencies and civil society in the capital and in the regions of Ukraine.

As a result of this activity, by the end of 2022, more than 28,000 photo and video files were generated in the EyeWitness to Atrocities app, and of understanding was signed between the EyeWitness to Atrocities project and the Office of the Prosecutor General of Ukraine.

During 2022, the UBA also supported the efforts of the Global Accountability Network Ukraine Task Force (GAN UTF) to gather open-source information on war crimes, crimes against humanity, and genocide committed by the Russian Federation in Ukraine.

About 50 UBA volunteers collected and analysed information that formed the basis of the GAN report on crimes of the Russian Federation in Ukraine from February to July 2022.



Euromaidan SOS and the UBA prepared and submitted to the OSCE Bureau of Democratic Institutions and Human Rights under the Moscow Mechanism a joint information report on Russia's war crimes in Ukraine.



Three members of the UBA were included in the mobile evidence collection teams created by the Office of the Prosecutor General jointly with Global Rights Compliance.

Aid to civilians during the war

Already on February 25, 2022, the next day after the start of the full-scale war, the Association established the Hotline for Free Legal Assistance to individuals and businesses affected by the war.

Since February, the Hotline has processed more than 5,000 requests, issued more than 20 guides with answers to the most frequently asked questions within various spheres of law, developed a guidebook on the rules of migration to 25 countries, and involved about 200 volunteer lawyers.

The most popular topics for legal consultations were:

- mobilization and completion of service;
- border crossing and migration;
- internally displaced persons;
- labour relations during the war;
- taxation.

With the support of the IBA, the Association developed a separate website https:// hotline.uba.ua/ for the Hotline, as well as a dedicated Telegram bot.



Assistance to lawyers during the war

In order to support Ukrainian lawyers, the UBA implemented initiatives aimed at:

— Provision of housing and visa support for lawyers who were forced to leave Ukraine. The Association became a platform for accumulating information from foreign colleagues and disseminating it among Ukrainian lawyers who need help. Among other things, the UBA also became a national partner of the Bar Council of England and Wales in providing housing for Ukrainian lawyers.



 Support with work and additional professional opportunities abroad. By developing constant communication and exchange of information with foreign associations, universities, as well as other organizations, the UB A has become a hub for assisting Ukrainian lawyers.

The story of Svitlana Pohribna, a participant in the housing search program in the United Kingdom.



Collection of funds and financial assistance to lawyers in need. The UBA and the "Kind Hearts for Ukraine" Charity Fund signed a memorandum on cooperation. 8 persons already received help in 2022. Someone needed treatment after being wounded at the front, someone lacked warm clothes after escaping from the occupation, someone needed funds to repair an apartment damaged and looted by the Russians. Someone was in a difficult situation without a job.

Daria Predmestnikova, Kherson, currently lives in Lviv: "I use various legal platforms at work, and on one of them, I saw that the Ukrainian Bar Association provides financial assistance to lawyers who suffered from the war. I immediately asked for help in purchasing warm things for our family. In the letter, I described my situation, I have a child in the first grade who, with me, scaped from the occupation. The UBA called me, then and I submitted all the supporting documents, after which the UBA agreed to provide





me with financial assistance. Thank you very much".

— Support with office premises. During the war and due to difficulties with electricity and the Internet, the UBA transformed its office into a co-working space and provided access to it to everyone who needed a place to work. In addition, the UBA partners in different parts of Ukraine also provided access to the offices.





 Assistance with relocation, office and informational support for lawyers from other regions was provided by JSC "Matviyev and Partners" in Lviv.



 Finally, the UBA, with the support of colleagues abroad, offers free membership to lawyers affected by the war. 10 lawyers have already joined us free of charge. Information on free membership is systematically updated on the organization's website.

Compensation for damages caused by war

From the very beginning of the full-scale aggression of the Russian Federation against Ukraine, the UBA, together with the New York State Bar Association (NYSBA) and international experts with experience in the UN Compensation Commission for Iraq and Kuwait, analyzed international legal mechanisms on the compensation of damages caused by armed conflicts, and relevant practices of other countries. Based on the collected information and in view of the national legislation, the Association developed proposals regarding a possible compensatory mechanism for damages caused by the aggression of the Russian Federation. The UBA proposals were transferred to the key national authorities in March 2022.

At the same time, the Association appealed to the governments of more than 30 countries with a request to conduct an audit of the property of the Russian state and its legal entities on the territory of the relevant jurisdictions with the aim of further confiscation of such property for the purposes of compensation.

Also, the Association supported the recognition of the Russian Federation as a state sponsor of terrorism, analyzed the US regulations on the issue, and formed a pool of American experts who specialize in sanctions and seizure of assets.

To ensure documentation of damages caused to individuals and legal entities, the UBA, together with the IBA, advances the usage of the EyeWitness to Atrocities app, which automatically verifies the recorded material and protects the data from editing. App coordinators were appointed in six regions of the country, where most combat operations are conducted. In addition, the UBA and IBA held a series of events for business associations aimed at dissemination of information on the EyeWitness to Atrocities as a reliable tool for documenting damage. In view of these efforts, the app has already generated more than 30,000 photos and video evidence, including evidence of destroyed buildings and infrastructure. All the collected material is ready for usage in court proceedings at the national and international levels to recover compensation for the damage caused to the Russian Federation.





COUNTERING AGGRESSION OF THE RUSSIAN FEDERATION

In cooperation with the Global Accountability Network (GAN), the Association collects information from open sources on war crimes of the Russian Federation committed on the territory of Ukraine, including the destruction of civilian infrastructure, state, and private property, theft and export of grain, destruction of agricultural lands, etc. Since the respective reports of GAN and the UBA cover every day of the war and record all the crimes committed by the Russian Federation in Ukraine, they also contain information that will strengthen the position of the state and private individuals in proceedings to recover damages caused to the Russian Federation.

In addition, the UBA Hotline, which provides free legal assistance to Ukrainian citizens affected by the war, also generates information on damage caused

to individuals and businesses. Since February 25, 2022, Hotline lawyers have provided answers to more than 5,000 requests, a large number of which relate to property damage.





The UBA committees have prepared a number of draft laws regarding the methodology of damages assessment, bankruptcy and enforcement of court decisions in cases in which one of the parties is a resident of the Russian Federation and other issues. In cooperation with the Supreme Court, the Association prepared a concept of lifting the sovereign immunity of the Russian Federation on the territory of Ukraine, followed by a respective draft law.

It is also worth noting that the Ministry of Reintegration of the Temporarily Occupied Territories of Ukraine included a member of the Board of the UBA in the Commission for Conducting an Audit of Damages Caused to Ukraine as the Result of the Armed Aggression of the Russian Federation. Other UBA members participate in the working group of the Ministry of Justice of Ukraine tasked with the development of a damages compensation strategy.

These and other measures of the UBA are aimed at supporting the efforts of authorities in resisting the aggression of the Russian Federation and developing compensation mechanisms, and this line of work remains a top priority of the legal community. To ensure the transparency and inclusiveness of the process of developing mechanisms for compensation for damage, as well as coordination of efforts, the Working Group on War Damages Compensation operates on the basis of the UBA.



INTERNATIONAL ACTIVITY

Integration of Ukrainian lawyers into the international legal community

 In 2022, the UBA offered the international community new forms of cooperation that made it possible to integrate more closely with the international legal market and receive support for continuing activities on the legal front

To this end, for the first time in its history, the UBA opened its doors to foreign lawyers and law firms, offering an option of international participation. More than 60 colleagues from abroad became international participants of the UBA.



And Greenberg Traurig law firm became the first international general partner of the UBA.



For the purpose of fundraising funds for charity, the UBA established a separate type of membership — "Honorary Patron". All funds raised via this membership are directed to charity for the provision of assistance to Ukrainian lawyers.



In 2022, the UBA members had the opportunity to become members of the New York State Bar Association (NYSBA) and it's International Section free of charge. About 40 Ukrainian colleagues took advantage of this opportunity.

In addition, the UBA members also received a discount for participation in the IBA Annual Conference, which was held in Miami, USA.



NYSBA's Ukraine Task Force was created for supporting Ukraine and Ukrainian citizens residing in the USA. NYSBA Branch in Ukraine, which operates on the basis of the Ukrainian Bar Association, has been as active participant in this initiative.


2. Awards

From May 18 to 21, the International Bar Association Mid-Year Leadership Meeting 2022 was held in Vilnius. It was attended by Anna Ogrenchuk, President of the Ukrainian Bar Association.









On June 21-22, 2022, the Summer Conference of the International Section of the New York State Bar Association (NYSBA) was held in New York. A separate panel discussion was devoted to the war in Ukraine. It was attended by: **Serhii Kyslytsia**, Permanent Representative of Ukraine to the UN, and **Anna Ogrenchuk**, President of the Ukrainian Bar Association, Head of the NYSBA Chapter in Ukraine.

In addition, the UBA committees, together with the Ministry of Justice of Ukraine and the EU project "Pravo-Justice," carried out operational monitoring of the legislation of Ukraine in the areas of the judiciary and the judicial system, criminal justice, forensic expert activities, execution of decisions and bankruptcy in the context of the war in Ukraine.



Based on the results of the monitoring, a report was prepared with proposals for amendments to the legislation in order to adapt the national legislation to the requirements of martial law.

Representatives of the legislative and judicial branches of government, representatives of private legal professions, and independent experts were involved in consultations within the framework of monitoring.



REGIONAL OFFICES

All 23 UBA regional branches continued to function stably in 2022. Their work was coordinated and supported by the Regional Coordinator.

Since the beginning of the war, regional branches have created a network of assistance to colleagues from regions where active hostilities took place. There was 24/7 communication regarding the provision of temporary shelter, humanitarian assistance, and assistance to colleagues who joined the ranks of the Armed Forces.

































REGIONAL OFFICES

The UBA branches in the city of Kyiv and in the Kharkiv region regularly gather funds, which are being used to purchase cars and equipment for colleagues who are protecting Ukraine on the front.



The branch of the Ukrainian Bar Association in the Lviv region, in cooperation with legal activists of Lviv, submitted proposals to the city council regarding the naming of Lviv streets after the names of prominent lawyers associated with Lviv. This initiative ended with the adoption of the name of Stepan Fedak for the alley between Doroshenko and Kopernyka Streets in the city of Lviv.

In 2022, 6 UBA members from Zaporizhzhia, Kharkiv, Sumy, Chernihiv, Odesa, and Mykolaiv regions became regional coordinators of the UBA and the IBA on issues related to the use of the EyeWitness to Atrocities app for recording evidence of war crimes. Regional coordinators collected photo and video evidence of crimes committed by the Russian Federation in Ukraine and advocated the use of the application by state authorities, local self-government bodies, and law enforcement agencies. Numerous meetings were held with authorities, law enforcement agencies and civil society in the capital and in the regions of Ukraine.

Regional branches of the UBA also participated in the collection of information by the International Legal Assistance Consortium (ILAC) regarding the functioning of the justice system of Ukraine during the war. The collected information will be used to prepare the updated report **Under Assault: A Status Report on the Ukrainian Justice System in Wartime**.

4 members of councils of UBA regional branches became members of the Public International Law and Policy Group (PILPG), which work on the preparation of the strategy for the Office of the Prosecutor General on the investigation of major international crimes (war crimes, crimes against humanity, genocide, and aggression).

The All-Ukrainian project "Give warmth to the defenders" — the League's Board initiated a project on the production of trench candles. In total, several hundred candles were made and already warm up our soldiers in Bakhmut.

The 4th wave of the charity auction of meetings "Coffee — a chance for life" has begun with the aim of purchasing half a dozen drones for the 24th brigade of the Armed Forces of Ukraine. Among the lots, there were famous lawyers, politicians, journalists, actors, and musical performers. UAH 86,700 have already been collected!

The branches initiated 3 charity lotteries to support shelters: the collection of electronic cigarettes for the production of power banks for the Armed Forces and the fundrasing money for yarn for the production of socks for defenders.

PR AND COMMUNICATION

Significant strengthening of international communications, the establishment of relations with foreign media, and a noticeable increase in the share of English-language content took place in the course of 2022.

Last year, the UBA was mentioned in mass media 3,102 times, which is an average of 240 references per month. Compared to last year, the number of references has doubled (in 2021, the numbers were 1,479 per year /123 on average per month). Importantly, 30% of media mentions in 2022 were of English-language content.









